#### Membership is flexible

There are different membership possibilities, as an individual or institution. The membership is valid one year from the date of registration.

#### Membership fee is recoverable

The membership fee is recoverable by federally-appointed judges under S. 27(1) of the Judges Act. Provincial and Territorial Judges, other judicial officers and board and tribunal members may be entitled to reimbursement through judicial or other professional allowances.

Membership fee varies according to the number of legal staff within the organization (per year):
