


### The BC RCMP

- BC RCMP Municipal, Provincial, Indigenous and Federal Police Service
- BC RCMP polices 99% of the geographic area of BC
- 72% of BC residents live in RCMP jurisdictions
- 144 Detachments serving 150 municipalities and 132 First Nations Communities
- Over 10,105 employees
- Answer over 1.4 million calls for service per year

One Port Alberni RCMP member sustained significant injuries during a struggle on Monday, Dec. 18.

On Monday afternoon, RCMP received a report of a male acting

irrationally in front of the courthouse. Members attended, but the individual had already moved on.

He later attended a business on Third Avenue, still acting irrationally, and RCMP were called to the scene to attend and assist. After observing the male, they informed him that he would be placed under arrest, at which point he bolted out of the business.

He was later found in a local apartment, and brandishing a knife when police officers showed up.

### Mental Health and interactions with police

- In 2012 Statistics Canada released a report titled "Mental health and contact with police in Canada"
- The study found approximately 1 in 5 people (18.5%) with a mental health disorder had contact with police – approximately 950,000 people in Canada
- This was double the rate for people without a mental or substance use disorder
- Not all contacts are criminal in nature

#### Mental Health and interactions with police

- In 2017 Public Safety Canada release a report titled "Crime Prevention: Youth Mental Health, Mental Illness & Crime"
- The report cited research which showed that certain disorders, including substance use disorders, had an impact of people offending or re-offending
- The report also found that gang members had a higher rate of mental health disorders

### Mental Health and interactions with police

- Some mental health clients can create a disproportionate number of calls for police assistance
- A study by one BC RCMP Detachment found 8 people with mental health needs were responsible for 1,500 calls to police in four years



### Policing perspective


- A continuous rise in mental health related occurrences
- The increase is being experienced across the province
- Most significant increase by percentage is in the North District which typically has smaller municipalities and less resources



### Policing perspective

- Smaller Districts (based on population) have a higher percentage of Mental Health Related police occurrences
- These areas typically have smaller Detachments and fewer police resources

### **RCMP Intervention tools**

- National Crisis Intervention De-escalation Course – mandatory for all police officers
- Trained Negotiators
- Less lethal use of force options – Pepper, Spray, Conducted Energy Weapons, 40mm Extended Range Impact Weapon



#### Mental Health and Crisis Response

• There are four possible police actions when dealing with a mental health or substance use crisis: Section 28 Police **Apprehension; Form 4 Medical** Certificate + Form 10 Police Apprehension; Form 21 Police Apprehension (Director's Warrant/ – extended leave recall); No Police Apprehension



#### Section 28 Police Apprehension/

Section 28 of the Mental Health Act authorizes police to apprehend an individual if an individual is behaving in a way that will endanger their own safety or the safety of others, and they apparently have a disorder of the mind that requires treatment and that seriously impairs the individual's ability to react appropriately to their environment or to associate with others

#### Form 4 Medical Certificate & Form 10 Police Apprehension

According to section 22(6) and section 28(5) of the Mental *Health Act*, an individual can be apprehended and transported to a designated mental health facility to be admitted and detained for treatment for a mental disorder if a physician has issued a Form 4 medical certificate or a judge has issued a Form 10 warrant.

# Form 21 Police Apprehension (Director's Warrant – extended leave recall)

 Under the Mental Health Act, a Director of a designated facility may issue a Form 21 warrant to apprehend and return an individual to a medical facility.

# Privacy of the Individual /

- Police have a responsibility to protect the privacy a person that they interact with
- We must ensure the security of personal health information
- Failure to do so can impact their lives, employment, future opportunities

#### Where we are

- Police are often the agency of last resort when dealing with people with mental health and substance abuse issues
- Larger Detachments or Police Forces can dedicate resources to mental wellness issues. Not feasible in smaller communities
- Confrontations that could result in injuries to both parties are possible
