FEDERAL CONFLICT OF INTEREST ACT — RELEVANT PROVISIONS

- Section 2(1) "Definitions"
 - Reporting public office holder is a GIC who exercises duties and function on a full-time basis OR exercises those duties on a part-time basis but receives an annual salary and benefits.
- Section 5 "General duty"
 - Every public office holder shall arrange his or her private affairs in a manner that will prevent the public office holder from being in a conflict of interest.
- Section 16 "Fundraising"
 - No public office holder shall personally solicit funds from any person or organization if it would place the public office holder in a conflict of interest.

BY THE NUMBERS

- 2022-2023 Quarterly Report of the Conflict of Interest and Ethics Commissioner (Jan to March 2023)
 - Reporting public office holders (full-time): 1,451 (557 GICs)
 - Public office holders (part-time): 1,493 (includes part-time ministerial staff)

DIFFERENCES BETWEEN FULL TIME AND PART-TIME ADJUDICATORS UNDER THE ACT

FULL TIME

- Disclosure of assets & liabilities on appointment
- Blind trust for some retained assets
- No income from outside sources
- Prohibitions on contracting/making representations post-employment

PART-TIME

- No financial disclosure required
- No requirement for blind trust
- No restrictions on outside income
- No contracting/making representations restrictions post-appointment

SIMILARITIES BETWEEN FULL TIME AND PART TIME ADJUDICATORS

No gifts of \$200 or more

Same recusal rules for individual hearings

Same rules for post-employment confidentiality

BEST PRACTICES

- Clear guidance prior to appointment on ethics/conflict of interest obligations
- Ethics advisor (in-house)
- Ethics scenario discussions at regular tribunal meetings
- Periodic ethics/conflict of interest training for all tribunal members
- Encourage a culture of proactive disclosure to avoid conflicts in the first place
