# THE EVOLUTION OF STATUTE REVISION



#### THE NEW BRUNSWICK CONTEXT

- A fully centralized drafting service
- Bilingual drafting services to all government departments and agencies
- Legal advice on proposals for and drafting of <u>ALL</u> new and amending Acts and regulations
- On-going revision of <u>ALL</u> Acts

#### BACKGROUND

 Last full revision and consolidation of New Brunswick legislation was published in 1973

Statute Revision Project initiated in 2001

 In 2003 the Statute Revision Act was enacted and the Statute Revision Manuals were produced LEGISLATIVE AUTHORITY: STATUTE REVISION ACT, s. 4(1)

- Make changes to achieve a uniform mode of expression
- Reconcile inconsistent provisions
- Revise archaic language
- Revise language for clarity

Improve language to make both language versions more compatible

#### CHALLENGES

- Staff changes and reductions
- Staff resources redirected to other government priorities
- Parameters of the project:
  - Not simply a consolidation
  - Mandate to make style and language consistent across legislation and between the two language versions
  - "Clean-up" up the French versions of the legislation

- External cross referencing issues
- Uncertainty over how to cite the Acts
- Alpha-numeric chapter numbers

#### Statute Revision Act

Section 3

**3** In accordance with this Act, the Committee may from time to time prepare, under the General supervision of the Deputy Attorney General, a **revision of any or all of the public Acts of New Brunswick**.
