

# HONORARY CHAIR The Right Honourable Richard Wagner, P.C., Chief Justice of Canada

The Right Honourable Richard Wagner has been Canada's chief justice since 2017. He also chairs the Canadian Judicial Council and the National Judicial Institute. Prior to his appointment to the Supreme Court in 2012, he practised law for more than 20 years and then served on the Quebec courts. An advocate for access to justice and judicial transparency, he has initiated several reforms to bring the courts closer to the public. He is recognised for his commitment to the rule of law and has received numerous awards, including the Medal of the Bar of Montreal and the Legion of Honour.

A renowned philosopher, Jason Stanley has dedicated over two decades to studying power, language, and their susceptibility to corruption. An expert on authoritarian regimes, he is the author of seven influential books, including *How Fascism Works: The Politics of Us and Them* (2018) and *Erasing History: How Fascists Rewrite the Past to Control the Future* (2023), where he examines the mechanisms of extremism and political manipulation. A professor at Yale University since 2013, he decided to leave not only the institution but also the United States in response to political pressures on academic institutions. In the fall of 2025, he will join the Munk School of Global Affairs and Public Policy at the University of Toronto as the Bissell Hyatt Chair in American Studies.
