

THERAPEUTIC COURTS FOR YOUTH: PROS, CONS AND ESSENTIAL COMPONENTS

This program will involve presentations from three panelists who have had significant experience and success with therapeutic courts. The focus of the program will be the process and workings of therapeutic courts which serve youth with mental health needs. The objective of the program is to assist members of the audience in identifying and supporting the mental health needs of youth in a timely manner. At issue here is whether this type of court, as opposed to traditional courts, is better able to address social and personal issues of a young offender - such as poverty, addiction, and/or mental illness - that are often associated factors with the criminal behaviour.

Criminal Code Review Boards are usually mandated to review the status of persons found unfit to stand trial and those found not criminally responsible because of mental disorder. Recognizing that mentally disordered persons may require a health- focused response rather than a penal response, the Canadian Criminal Code Review Board stakeholders will examine Atlantic Canada's preparedness to respond to youth at risk, in particular.

Panel members will discuss the possibility of strengthening our capacity for an earlier response, ostensibly in the name of enhanced public safety and to optimize positive outcomes for youth. As well, they will examine the use of a person/family centered approach as opposed to the current fragmented approach to mental health and justice.
