MESSAGE FROM THE PRESIDENT

Dear CIAJ Members,

Over the past year, CIAJ provided an unprecedented number of training activities and programs. The successes that we've had are based first and foremost on the faithful collaboration of our members and partners. Without your availability and generosity, CIAJ would simply have been unable to provide such high-quality activities, and I want to thank you very much for that.

We also owe our successes to the tireless work of our staff, skilfully motivated and led by Christine O'Doherty, and to the vital contributions of the members of the Board of Directors and its committees. I would be remiss if I did not mention the outstanding contributions of the members of our Executive Committee, the Honourable Georgina Jackson, Colleen Suche, James O'Reilly, Catherine Pilon and Mr. Mark Benton. Thank you for sharing your experience and insights with CIAJ.

The challenges that our justice system is facing are well known to everyone. The issues of accessibility and delays are still priorities, despite the efforts to mitigate the impacts. From this perspective, CIAJ has set up a series of roundtables dealing with the delays in criminal justice and with jury representativeness. We hope the recommendations that will come out of those roundtables, held in various provinces and regions of Canada, will inspire decision-makers for the reforms needed, whether administrative or legislative.

This year, CIAJ further expanded its service offering to a number of administrative tribunals and specialized agencies. Those training sessions, designed to meet the needs specific to each one, cover best practices in decision writing. Their primary objective is to facilitate readability of those decisions and thereby make justice more accessible across the country. We also undertook and completed the updating of our strategic plan, following a number of consultations with our partners and the communities we serve. Our institutional directions for the 2020-2023 period are backed by the expertise that sets us apart and by a forward-looking assessment of how the justice system will evolve. Just as an example, we can see that advances in artificial intelligence are inevitably going to influence how the courts and tribunals operate. The same is true of the place that social media already occupy in our societies. That was the topic of our annual conference in 2019.

I look forward to seeing you at our next annual conferences. The one in October 2020 to be held in Vancouver will deal with the interactions among Indigenous peoples and the administration of justice. In October 2021, the conference will be held in Halifax and will address the subject of the right to dignity. In October 2022, in Ottawa, our discussions will be on the law of borders. I hope to have the pleasure of seeing you there!

Dear Members,

After three years at the helm of CIAJ, I still enjoy working here. The team has expanded, we've moved into better suited offices, and the volunteers across the country continue to dedicate themselves on a daily basis to improving the administration and accessibility of justice. One step at a time. One activity at a time.

I would first like to pay tribute to CIAJ's many volunteers and partners who help us deliver relevant, high-quality programs. We are very fortunate to have a network of such skilled and dedicated professionals to rely on. These players, from all backgrounds in the legal community, enable us to better understand the specific realities and issues of Canadian communities in order to deliver programs that are geared to people's needs.

This past year was again distinguished by the increase in the number of programs provided by CIAJ and, consequently, by the increase in the number of speakers and participants in those programs. We are proud to be able to provide a large number of customized training sessions in decision writing, mediation, and the conducting of hearings. Increasingly more administrative tribunals are calling upon the expertise of CIAJ and its instructors for enhancing or updating their knowledge.

The surveys that we conduct among the participants after each training session are extremely positive. The decision-writing training in particular has proved to be very helpful for the participants. That training addresses a growing need among the organizations for improving their organizational performance and, thereby, access to justice.

CIAJ wants to make a tangible contribution to improving the administration of justice and its accessibility for people for many years to come. To do so, it has to keep innovating. An overview of our most recent initiatives appears on pages 8 and 9 of this report.

The CIAJ Board of Directors conducted an evaluation of its 2016-2019 strategic plan. The results obtained are very positive. There is still work to do in terms of CIAJ's visibility and the diversification of its revenue sources. The next strategic plan will be approved at the October 2019 Board of Directors meeting and will be posted on CIAJ's website.

CIAJ will celebrate its 45th anniversary next year. We hope you'll be there!





ROUNDTABLES ACROSS CANADA

In 2018-2019, we held two roundtables on criminal delays (in Alberta and Nova Scotia) and two roundtables on jury representation (in Manitoba and British Columbia). These sessions generated dynamic and sometimes challenging discussions. The roundables have resulted in recommendations that will be implemented in the medium term. In Manitoba, for example, the discussion provided access to a wealth of data on system failures related to the Juror's Act. After the roundtable, administrative changes were immediately made to the jury selection process.

In addition, the participation of court administrators has been extremely positive. Their presence has helped to identify policies that create barriers and to find solutions. Further roundtables are planned for 2019-2020.

2019 SURVEY

CIAJ conducted a new survey of its members and partners as part of its 2020-2023 strategic planning.

More than 1600 people were contacted. Among other things, our members would like CIAJ to develop more training programs targeting specific issues. Our members also hope these activities continue to exploring solutions to current problems in the justice system.

Access to justice, criminal delays and reconciliation with First Nations continue to be important issues for CIAJ members. Webinars and training programs accessible in outlying regions are also among the priorities.

FOR LAW STUDENTS

Several initiatives have been launched this year in order to involve law students in CIAJ's work. By participating in these activities, students become aware of the issues connected to the administration of justice and its accessibility.

More than 155 students from across Canada have applied for judicial internships through CIAJ. Some of them had the opportunity to shadow a judge from a Superior Court or Court of Appeal in their province for a week. CIAJ is proud to have facilitated such meaningful and educational experiences for law students.

ONLINE LIBRARY

CIAJ's website is regularly enriched with new features and contains over 1000 high quality documents: educational material provided by our instructors, webinars, videos, papers, articles and reports on a variety of topics. CIAJ's online library is accessible to everyone.

In addition, we are proud to begin a new collaboration in 2019 with CAIJ, a "legal information broker" with over 30,000 members. CAIJ will provide us with a new platform, distributing various elements from our online library to its members across Canada.

COMMUNICATIONS

CIAJ strives to continue raising awareness of its activities among Canada's legal community.

The regular use of social media attracts new customers and allows us to promote our activities to a growing number of subscribers.


CIAJ's blog (on our website) provides a great platform for our collaborators to express expert points of view, while highlighting our activities and the issues that are important to us.

Our newsletter opening rate is increasing, reaching 39%. This is a promising statistic, considering that a 32% opening rate is commonly considered excellent.

ROUNDTABLES ACROSS CANADA

In addition to offering various training programs, CIAJ has developed two series of roundtables on current topics important to the legal community and the population across Canada.

These roundtables are a way for CIAJ to contribute directly to the improvement of the administration of justice. They bring together numerous academics and decision-makers (judges, Crown counsel, defence counsel, representatives of organizations that provide legal services to the public) to explore effective solutions to improve the justice system and make it more accessible.

CRIMINAL DELAYS

The goal of these individual roundtables is to discuss the pressing issue of lengthy criminal delays in a given jurisdiction, particularly after the influential Supreme Court of Canada decision *R. v. Jordan*. Each meeting is followed by the publication of a report which is made available on our website. A national symposium may be held at the end of the process, to share ideas and perspectives from each province, with the goal of presenting concrete recommendations in a report representing a national outlook on the issue of criminal delays in Canada.

PRESIDENT'S AWARD

In 2016, CIAJ established the President's Award to highlight the exceptional contribution of one of its volunteers. The Award is given every other year, alternately with the Justice Medal.

The 2018 President's Award was given to the Chief of the Commission and Tribunals of the Alberta Human Rights Commission, Mr. Michael Gottheil.

MR. MICHAEL GOTTHEIL

Michael Gottheil was appointed Chief of the Commission and Tribunals of the Alberta Human Rights Commission and began his term in August 2018.

Mr. Gottheil brings many years of leadership experience in the Administrative Justice sector, having previously served as Chair of the Human Rights Tribunal of Ontario, and Executive Chair of both the Environment and Land Tribunals Ontario and the Social Justice Tribunals Ontario, which is comprised of eight tribunals. Mr. Gottheil is a firm believer in justice, as a means and an end, and has worked to foster collaboration among those in the legal community, as well as civil society more broadly.



RESEARCH FELLOWSHIP

Created in 2009 in honour of a former CIAJ President, the Charles D. Gonthier Research Fellowship of \$7,500 supports research in relation to the topic of CIAJ's Annual Conference. Each conference focuses on a specific aspect of CIAJ's themes:

- ·Justice as a humanistic and social value
- ·Justice as a public service
- Justice in a global economy and interdependent world

The 2019 Research Fellowship was given to McGill Faculty of Law Professor, Mr. Ignacio Cofone for his research on "Regulating Algorithmic Transparency in the Administration of Justice." Mr. Cofone is invited to present his findings at CIAJ's 2019 Annual Conference.

PROFESSOR IGNACIO N. COFONE

Professor Cofone teaches Privacy Law, Business Associations, and Artificial Intelligence Law. His research explores how the law should adapt to technological and social change with a focus on privacy and algorithmic decision-making. In his latest projects, he proposes how to evaluate harm in privacy class actions and how to prevent algorithmic discrimination.



ESSAY PRIZE

The Christine Huglo Robertson Essay Prize aims to engage law students in the work of CIAJ and promote scholarship regarding the administration of justice.

The 2019 Essay Prize of \$1,000 was awarded to an Université de Montréal Faculty of Law student, Mr. Xavier Dionne, for his essay entitled: "Sur les épaules de robots : l'impact de l'intelligence artificielle sur la propriété intellectuelle" (On the Shoulders of Robots: The Impact of Artificial Intelligence on Intellectual Property). Mr. Dionne was invited to present his Essay at CIAJ's 44th Annual Conference. This prize was created in honour of CIAJ's Executive Director from 1992-2012.


MR. XAVIER DIONNE


ABOUT OUR MEMBERS
