# MESSAGE FROM THE PRESIDENT

#### Dear CIAJ Members,

We are all experiencing unprecedented circumstances. Each of us is navigating the COVID-19 pandemic as best we can to protect ourselves and our loved ones. We are simultaneously trying to preserve the fundamental institutions of civil society, our critical infrastructure, commercial enterprises, charitable agencies and, yes, not-for-profit organizations like CIAJ.

CIAJ is an organization with a core mandate to bring people together to exchange perspectives, ideas and proposals to advance the administration of justice. In the circumstances of a pandemic, when people simply cannot come together, what role can CIAJ play?

The pandemic presents an existential challenge for CIAJ. But a challenge presents an opportunity to reconceive our mandate, rethink how we do things, and reconstruct the means by which we do them. For the past several months, all of us involved in CIAJ have been working diligently to meet the challenge before us and explore the opportunity it presents us.

It is the staff, though, who have done most of the work. To say that our Executive Director, Me Christine O'Doherty, has performed heroically would be to understate her contribution. She has been a constant source of new ideas, sound advice, and cheerful communication. I doubt we could have weathered the past months without her guidance and determination. She has helped, of course, and we are fortunate to have a strong and energetic staff at our head office in Montreal. We owe them our deepest gratitude.

These efforts have enabled us to deliver some of our core programs in new ways. For example, we offered our perennial National Roundtable on Administrative Law in a virtual format. For other programs, like our Judgment Writing Seminar, we will probably want to preserve the in-person experience. So much learning and guidance in that program come from casual conversations over lunch, at breaks, and within workshops, which simply cannot be replicated in a virtual environment. Even so, we managed to deliver the seminar this year on an online platform. It was a tremendous challenge to combine lectures, workshops, and tutorials across six time zones simultaneously. Yet, it worked. In fact, evaluations suggest that some participants preferred the online format over an inperson experience.

Finally, we have been exploring new types of programs—virtual roundtables, webinars, and webcasts. For example, we staged a highly successful webcast involving a conversation between Chief Justice Richard Wagner and Professor Richard Susskind, an expert on the future of courts, which was attended by 650 people. With that triumph, we are exploring other speakers and topics that will appeal to our members and partners. Stay tuned.

In the meantime, be safe and well. I hope to see you soon, either in-person or on-screen.

I hope you are doing well. What a year we've had! And it's not over yet. First, I want to thank the small and dynamic team at CIAJ, my colleagues who have put in countless hours and efforts to adapt to the special circumstances of working at home and the new online programs. 

All these changes have not prevented us from planning the next annual conference on Indigenous Peoples and the Law, which has been postponed to November 17-19, 2021 in Vancouver. We hope that this conference will be held in person to enrich the experience. In addition, and in order to reflect on the important issues of reconciliation and a relationship of equals Indigenous Peoples, CIAJ is proposing a series of activities beginning in October 2020 and continuing until November 2021. A first series of webinars in collaboration with Courthouse Libraries BC will focus on the calls to action emanating from the Truth and Reconciliation Commission of Canada Final Report. These six webinars (running from October 14, 2020 to March 10, 2021) will allow us to take stock of their implementation. These webinars will be followed by podcasts and other online programs. We also want to continue to hold roundtable discussions on the issue of jury representation, where possible. Other activities will follow during the year. We suggest that you visit our website regularly and subscribe to our newsletter in order to stay informed of all our upcoming projects.

I would also like to invite you to share your ideas for seminars, webinar series and podcasts. We will be happy to make them happen.



#### ADAPTING TO CHANGE IN AGILE MODE

The pandemic has changed the way we do things. The justice system has been particularly affected by the crisis and continues to adapt. CIAJ's team is made up of seven people. A small team that has been working hard to deliver relevant and quality online programs since March 2020. And we will continue to do so, as the response to this training offer has been very positive.

CIAJ's 45<sup>th</sup> conference on Indigenous Peoples and the Law should have taken place in October 2020. It had to be postponed to November 17, 18 and 19, 2021. This is the first time in CIAJ's history that an annual conference has been postponed in this way. We have rescheduled this program, as it is a very important topic that we feel should take place in person. In the meantime, we have decided to develop a series of six free webinars on the same theme.

#### **KEEP LISTENING**

CIAJ can and wants to do more. In order to achieve this, we strive to provide more forums for dialogue and learning open to all individuals and groups who are interested in the administration of justice.

The discussions in these forums are open and friendly and are also driven by a genuine desire for improvement on the part of all those involved.

CIAJ is fortunate to have representation and allies among all members of the legal professions across the country. This valuable asset allows us to stay abreast of important developments and issues. It also allows us to offer our support in return where it is needed, with the added advantage of having an overview of the legal community.

#### **KEEP GROWING**

Since last year, CIAJ programs have seen their participation rate increase by more than 27%. 8393 new visitors have visited our website, an increase of more than 35%. The number of members has grown from 1000 to 1500 in just a few months. More than 780 new subscribers have been added to our newsletter.

CIAJ is very enthusiastic about these very encouraging results. This support from the legal community is a key element of our success. It allows us to move forward with confidence, and to continue our work in order to improve the administration of justice. And doing so, access to justice is enhanced for all members of our society.

#### **RESPONDING TO NEEDS**

From the outset of the pandemic, CIAJ has managed to offer a series of free webinars on "what do to when crisis strikes" which have been well attended. It was clear that we had responded to a need and that it was relevant to produce more content of this type online.

The CIAJ team quickly developed the skills required to hold CIAJ's signature program on judgment writing (originally designed for federally appointed judges) entirely online. 56 judges participated in this program, which was a great success. Some participants even felt that it should always be held online.

The example of the superior courts convinced the Court of Québec to get more training sessions online. The coming year will therefore allow us to train several judges and members of administrative tribunals on how to write judgments and decisions, thanks to the technology.

#### **ADDRESSING KEY ISSUES**

Over the past few years, CIAJ has undertaken a series of projects aimed at strengthening the administration of justice while addressing major issues. These key issues include such themes as the impact of artificial intelligence and social media on legal institutions, mental health, civil justice and the economy, and cultural and religious diversity in the administration of justice. CIAJ has also undertaken a series of projects related to Indigenous Peoples in Canada.

# BUILDING BRIDGES WITH INDIGENOUS PEOPLES

CIAJ's activities and programs are vehicles for dialogue.

For example, one of our core projects is to build bridges and contribute to better relations with Indigenous Peoples. To achieve this, we have developed a set of activities.

A first CIAJ annual conference on "Indigenous Peoples and the Law" was held in 2015, following the final report of the *Truth and Reconciliation Commission*.


In 2018, CIAJ began its work on the representation of Indigenous peoples on juries. A series of four provincial roundtables followed in British Columbia, Alberta, Manitoba and Atlantic Canada, with more to come.


The 45th annual conference was scheduled to take place in october 2020, one year after the final report of the National Inquiry into Missing and Murdered Indigenous Women and Girls. It has been postponed, but we have moved quickly to find new avenues.

For example, we developed a series of 6 webinars on the implementation of normative changes as requested by the *Truth and Reconciliation Commission*, as well as those of the Quebec Inquiry, in collaboration with Courthouse Libraries BC. This webinar series will run from October 14, 2020 to March 10, 2021

These projects were designed in collaboration with Indigenous leaders, but also with CIAJ's Circle of Indigenous Peoples, a group of Indigenous lawyers, judges and professors.

The discussion is well underway, and we hope that many of you will join in.

#### WEBINARS & NATIONAL ROUNDTABLE

There were four webinars on administrative law: two in English and two in French.

"New Standard of Review: The Essentials" was held on January 30, 2020 thanks to the technical support of the Federal Court of Appeal. It brought together 165 participants for the English session and 52 for the French.

"Six Months of Vavilov, Where Are We Now? was held on May 25 and 26, 2020 and brought together 85 participants for the English session and 14 for the French.



# CUSTOMIZED PROGRAMS 2019-2020

In 2019–2020, CIAJ delivered seven customized training programs in both official languages, for diverse organizations, courts and tribunals. However, many trainings were cancelled or postponed due to the COVID-19 pandemic.

With its experience in legal training over the past 45 years, and drawing on its extensive network of experts, including experienced judges, leading academics, lawyers and consultants from across the country, CIAJ is one of those rare national organizations that provide training programs to all players in the judicial system, in both official languages. It's diverse clientele gives CIAJ a unique perspective on current issues, so it can address the specific needs of different legal actors in Canada.

#### JUDGMENT WRITING

#### Cour du Québec

This program includes lectures, discussions, and workshops that stress the nature of good prose, point-first writing and the special requirements and special challenges of judicial writing. Each judge is assigned an instructor who reads a sample of the judge's writing prior to the training.

#### **ROUNDTABLES ACROSS CANADA**

In addition to offering various training programs, CIAJ has developed two series of roundtables on current topics important to the legal community and the population across Canada.

These roundtables are a way for CIAJ to contribute directly to the improvement of the administration of justice. They bring together numerous academics and decision-makers (judges, Crown counsel, defence counsel, representatives of organizations that provide legal services to the public) to explore effective solutions to improve the justice system and make it more accessible.

Meetings were suspended in 2019 due to the pandemic and are expected to resume over the course of 2021.

#### **CRIMINAL DELAYS**

The goal of these individual roundtables is to discuss the pressing issue of lengthy criminal delays in a given jurisdiction, particularly after the influential Supreme Court of Canada decision *R. v. Jordan.* Each meeting is followed by the publication of a report. A national symposium may be held at the end of the process, to share perspectives from each province, with the goal of presenting concrete recommendations in a report representing a national outlook on the issue of criminal delays in Canada. It will be important to resume these roundtables and examine how the system can respond to situations such as a pandemic.

#### **JURY REPRESENTATION**

This series of roundtables was initiated by the members of CIAJ's Circle of Indigenous Peoples and addresses the issue of systemic barriers to the representation of Indigenous peoples and racialized minorities on juries in Canada. A research project on the status of juries across Canada was conducted by CIAJ and is available on our website. Each meeting is followed by the publication of a report. A national symposium (fist planned in late winter 2020, to be rescheduled), will discuss the various recommendations coming from the provinces.

### UPCOMING PERMANENT PROGRAMS 2020-2021

CIAJ's permanent programs are offered in both official languages with simultaneous interpretation. Most are accredited in provinces where CLE requirements for lawyers are mandatory. Programs for judges are approved under Section 41 (1) of the Judges Act.

These programs include CIAJ's flagship annual conferences. Every year for the past 45 years, these events have been building bridges between justice and non-justice experts, gathering different viewpoints, and contributing to solutions that enable change.

In the aftermath of the COVID-19 pandemic, some of the upcoming 2020-2021 programs that usually take place in person have already been moved online. CIAJ is monitoring the situation closely and will be adapting its programs on a regular basis.

#### JUSTICE MEDAL

At CIAJ's tenth Anniversary, in 1984, the Board of Directors established a Justice Medal Award to be given every second year as a mark of exceptional achievement to a person who has shown distinctive leadership in the administration of justice in Canada, or by his or her writings or other endeavours, has made a significant contribution to the administration of justice in Canada. Recipients are announced at CIAJ's Annual Conference in the fall. The next Medal will be given at the 46th Annual Conference, in the fall of 2022.

#### **2019 LAUREATES**

The 2019 Justice Medal was awarded jointly to Mr. John McCamus, Professor Emeritus and former Dean of Osgoode Hall Law School, and Affiliated Scholar at Davies Ward Phillips & Vineberg LLP, and to The Honourable Patrick J. LeSage, C.M., O.Ont., Q.C., former Chief Justice of the Ontario Superior Court of Justice.







Created in 2009 in honour of a former CIAJ President, the Charles D. Gonthier Research Fellowship of \$7,500 supports research in relation to the topic of CIAJ's Annual Conference.

The 2020 Research Fellowship was given to Dalla Lana School of Public Health, University of Toronto PhD student Tenzin Butsang for her research on "Kijibashik - Turn it Around: Stories About Motherhood from Previously Incarcerated Indigenous Mothers in Ontario." Ms. Butsang is invited to present her essay at CIAJ's 45th Annual Conference in November 2021.

#### **TENZIN BUTSANG**

Tenzin Butsang is interested in understanding the intersections between health inequity and the criminal justice system through community-led research. She received a Bachelor of Science from the University of British Columbia in 2017 and recently completed a Master of Public Health in Indigenous Health at the University of Toronto, where she will be undertaking a PhD in Social and Behavioural Health Sciences.



#### **ESSAY PRIZE**

The Christine Huglo Robertson Essay Prize aims to engage law students in the work of CIAJ and promote scholarship regarding the administration of justice.

The 2020 Essay Prize of \$1,000 was awarded to a McGill University Faculty of Law student, Michelle Pucci, for her essay entitled: "Who sets the course in a health crisis response?" Ms. Pucci is invited to present her essay at CIAJ's 45th Annual Conference in November 2021.

The prize was created in honour of CIAJ's Executive Director from 1992–2012.

#### A GROWING COMMUNITY

We are happy to report that over 600 new members joined CIAJ this year! This growth is partly due to our shift in hosting multidisciplinary and bilingual programs in a virtual format. This change has given us the opportunity to reach different groups of professionals across Canada, as well as abroad. Increasing the diversity in our membership has enriched our community and helped bring interesting and new perspectives to our discussions.

#### **GIFT MEMBERSHIPS**

With the help of our members and community, CIAJ is able to create programs that support the next generation of justice ambassadors in Canada. In 2019-2020, through the generosity of a few members, 43 one-year memberships were paid for and donated to students and young lawyers. This is a wonderful way to contribute and grow our member community. These memberships also helped foster multiple CIAJ student/young lawyer programs. For instance, we were able to place 13 students in courts through our "Judicial Internships Across Canada" program.

#### **JUDICIAL INTERNSHIPS**

In the summer of 2019 CIAJ launched the Judicial Internships program to place law students with judges for a week or two of handson legal education. The program is designed to allow students additional avenues beyond those offered at their faculties to gain practical experiences during their studies. Participating courts are given wide latitude to modify the experience to fit the needs of the student and the judges with whom they have been paired. Applications go through a double screening process whereby CIAJ reviews the initial submissions to pass on the stronger candidates to the participating courts which themselves can accept or refuse to take on any individual student.

The first year saw 155 applicants from 9 provinces, the majority of which came from Quebec and Ontario, followed by British Columbia and Alberta. In total CIAJ was able to have 5 students placed with judges, two in Toronto, two in Calgary and one in Fredericton.

Despite the onset of the COVID-19 pandemic, 2020 saw a greater placement of students. In 2020 CIAJ received 92 applications, the strong majority of which came from Quebec, and just over a quarter from Ontario. Thanks to the support of the honourable justice Claude Dallaire, 12 students received placements with several judges at the Superior Court in Montreal. Additionally, CIAJ placed 1 student at the Supreme Court of Newfoundland and Labrador at the Duckworth St. Courthouse with the honourable chief justice Raymond P. Whalen. The restrictions imposed by the COVID-19 prevented the courts which had to agree to participate in the program in Ontario from accepting applications from the 2020 cohort.

The feedback that we have received from students indicated extremely positive results. Students not only learnt from judges, but also from the lawyers they observed. As participation is voluntary, the judges who take on students seem to want to give them as good of an experience as they can get, and so the students get to see a variety of cases while also being able to draft legal memos and perform legal research for the judges. Moreover, students can begin building their network and open up other opportunities for themselves all while becoming more familiar with the day to day workings of the law.

#### THE STUDENT SECTION

CIAJ welcomed the introduction of the first president of its Student Committee Viviane Lavergne in 2020. The addition of the president is meant to formalize the projects of the committee to better implement them. In consideration of the success of the Judicial Internship program, the focus of the Student Committee for the following year is to put into place projects that give law students more opportunities to learn the practical skills needed to practice law. With the Student Committee composed of law students from around the country, the committee is in a good position to evaluate some common needs of law students such as the development drafting skills, researching skills, legal writing and even argumentation. With the ability to readily host webinars, CIAJ is well prepared to meet the needs of law students with virtual should the pandemic last longer, and even incorporate virtual access to programs permanently once people can gather safely together once again.






# ABOUT OUR MEMBERS 2019-2020



#### **EXECUTIVE COMMITTEE**

The mandate of the Executive Committee is to recommend new directors and honorary directors for election to the Annual General Meeting in order to fill vacancies. The Committee reports to the Board of Directors on current CIAJ operations in addition to recommending any changes to employment conditions. They analyzed the audited financial statements as of June 30, 2020 and they recommend the adoption of the 2019–2020 report of the Auditors Massie Turcotte and Associates Inc. For the fiscal year 2019–2020, revenues are at \$1,305,762 and expenses for seminars and conferences are at \$1,258,064 creating a surplus of \$47,698. When we add net administrative expenses, we have a slight deficit of \$14,452. As of June 30, 2019, CIAJ has a fund balance of \$317,286.
