# MESSAGE FROM THE PRESIDENT

For the third year CIAJ had to navigate, innovate, and react in a Covid-affected environment to deliver programs. But we've managed to do it. With considerable success.

The year began with our annual conference on Indigenous People and the Law, which brought together Indigenous leaders, academics and community representatives to speak about the progress, challenges, and evolving issues in achieving self-determination and meaningful reconciliation with Canada.

The conference was enormously successful and has resulted in several new programs and collaborations for CIAJ, among which a roundtable on Indigenous courts, planned for late fall of 2023, and a series of podcasts on CIAJ's *In All Fairness* series.

The conference also made two things clear: first is that despite logistical, technical and time zone challenges, a hybrid model can deliver high quality user-friendly programming. Second, is the importance to people of being able to gather. For those who were in Vancouver, the mood in the room was somewhat like emerging into the sun after a long winter storm. But this feeling was short-lived, as a real storm unfortunately hit the province, disrupting the lives of many people.

Then, the omicron variant emerged just weeks later. It wasn't until May that in-person programs returned. And there could be no better way to celebrate this, than to co-host the Honourable Rosalie Abella dinner. An intense and wonderfully varied program brought speakers from around the world-mostly by video-and across Canada to recognize and honour a beloved and respected jurist. Programming has continued with a mixture of in-person, hybrid, and online formats. Some activities shut down by Covid such as international outreach are now possible to pursue.

One of CIAJ's core activities is delivering customized decision writing courses for the judiciary, administrative tribunals and decision makers and recently, indigenous courts. Under the leadership of Justice James W. O'Reilly, work is underway to expand this series. Writing Reasons in Sexual Assault cases is on offer for the judiciary in November; another program focussing on children's testimony is planned for 2023. Our work with a wide variety of tribunals is also ever increasing.

In terms of the Board's activities, work on a Strategic Plan for 2024-2027 has started and will be presented to the Board next year. We will welcome several new directors at our annual meeting in October as we also say farewell to Justice Michelle O'Bonsawin, who embarks on her new role as a member of the Supreme Court of Canada, and Athanasios Hadjis, recently appointed as a member of the Canadian Human Rights Tribunal. Thank you both for your contribution and we hope you will continue to collaborate with CIAJ.

CIAJ's growing success results from the hard work and true dedication of many people. Few organizations can turn on a dime, as the expression goes, but this is one of CIAJ's core strengths. Credit for it all goes first and foremost to our small but talented staff led by Christine O'Doherty. They are a creative, flexible and resourceful team, and on your behalf, I offer a huge thanks to them. Meeting the standard they set is an army of volunteers—directors, committee members, annual program faculty and the many presenters who share their knowledge and expertise. No wonder CIAJ is thriving.

To all of you, dear members, volunteers, participants and speakers,

This third pandemic year has led us to be ever more flexible and creative in delivering relevant education programs. As we all know, there is a lot of online education to choose from. So, thank you for your continued trust and support.

This year, two major conferences kept us busy: one on Indigenous Peoples and the law and the other to mark the retirement of the Honourable Rosalie Abella. These events were held in person and were very successful thanks to the participation of outstanding speakers.

This success is also due in large part to your involvement. Many of you have joined us for these educational events and activities, both in person and online. We are extremely grateful for this.

In this word last year, I noted how CIAJ is seeking to embody its slogan: Listening, Learning, Leading.

In an ever complex world, where we need to be sensitive to the realities lived by the most vulnerable populations, it is important to listen to and include these many perspectives into our training programs. The views of Indigenous peoples, of people living with disabilities, LGBTQ+ groups and other vulnerable populations must be considered in the design of our programs. Our upcoming annual conferences on Dignity and Law of Borders will address these timely and sensitive issues.

There is still much to be done, but there are many initiatives that give hope. CIAJ supports the work of the National Action Committee on Civil and Family Matters and is involved in a Canadian initiative to reform the family justice system. We continue to be an agent of change on the path to reconciliation with Indigenous peoples. We participate in a few research projects on the digitization of the justice system, jury representation, and self-represented litigants. There is no shortage of work.

We know that the system is not perfect. The severe lack of access to legal services for certain populations is sometimes discouraging. But I assure you that the people with whom I work every day, the volunteers on the CIAJ Board and committees, the many instructors with whom we are fortunate to work, our partners, the law students who are just beginning to become engaged in their profession, are all committed to maintaining the integrity, efficiency, and inclusivity of the justice system.

I would also like to acknowledge the exceptional work of my small staff team, who work very hard to deliver quality programs and tools. You are extraordinary!




### ORGANIZATIONAL CHART





# HIGHLIGHTS OF THE YEAR

In 2021-2022, 500 law professionals attended CIAJ's flagship annual conference on Indigenous Peoples and the Law, which had been postponed in 2020 because of the pandemic. Over 250 more were present for another major national event honouring the career and legacy of the Honourable Rosalie Abella. Episodes from our podcast "In All Fairness" were downloaded over 25,000 times in a year and a half.



# CONFERENCE ON INDIGENOUS PEOPLES AND THE LAW

CIAJ's activities and programs are vehicles for dialogue. One of our core projects is to build bridges and contribute to better relations with Indigenous Peoples. To achieve this, we have developed a set of activities over the years.


CIAJ's conference on Indigenous Peoples and the Law was postponed one year because of the pandemic. It took place in Vancouver and online from November 17-19, 2021.

Over the course of the three days, eight panels composed of Indigenous elders, judges, lawyers, academics as well as non-Indigenous legal professionals discussed issues ranging from Indigenous self-governance and legal orders to child welfare and the experiences of Indigenous students in law school. Collectively between inperson and virtual attendance, close to 500 people were able to participate.

# "ASSERTING SELF-GOVERNANCE" A REPORT FROM THE CONFERENCE

A report compiling the highlights of invaluable analysis, comments and recommendations that emerged from the conference was released on National Indigenous Peoples Day, in June 2022. This report is available on CIAJ's website, in both official languages. Throughout the various topics discussed, a fundamental issue arose: Indigenous selfgovernment. Not a panel passed without its mention. Self-determination was the narrative either from which discussion began or culminated to. The report reproduces the aspects of Indigenous self-government that were highlighted and recurred throughout the conference. Three general areas were covered: the *United Nations Declaration on* the Rights of Indigenous Peoples as a legal instrument, the legal narratives of Indigenous self-governance, and Indigenous laws and the inherent right to self-governance. # THE HONOURABLE MURRAY SINCLAIR HONORARY CHAIR

The conference welcomed some thirty speakers, most of which were representatives of Indigenous Peoples across Canada and key players in the justice system.

The program was chaired by The Honourable Robert J. Bauman, Chief Justice of British Columbia and of the Court of Appeal of Yukon. Here is some words from The Honorary Chair, The Honourable Murray Sinclair:

Over the years, CIAJ has been providing an essential space for representatives from Indigenous communities to share their perspectives and aspirations with legal professionals and all Canadians. I hope that together, we can improve our children's lives and build a better world."









#### THE HONOURABLE ROSALIE SILBER-MAN ABELLA: A LIFE OF FIRSTS

This two-day conference was organized jointly by the uOttawa Public Law Centre, the Canadian Institute for the Administration of Justice, the Human Rights Research and Education Centre, and The Advocates' Society. The event took place on May 12 and 13, 2022, and brought together about 250 law professionals and friends of Justice Abella.

The program was set up to mark the retirement of the Honourable Justice Rosalie Silberman Abella from the Supreme Court of Canada (on July 1, 2021), and to highlight her influence on law and society. The event brought together some 65 speakers from Canada and abroad. Over 250 participants attended the event, in person or online.

The conference kicked off on Wednesday, May 11, 2022 with a welcome reception and art exhibit at the National Gallery of Canada. All participants and friends of Justice Abella were invited to admire 9 carefully selected works, with special comments explaining

their links with Justice Abella's background and personality.

Renowned lawyer Guy Pratte (Partner at BLG) was the Master of Ceremonies for a memorable banquet taking place on Thursday, May 12, 2022. Among the many homages that were delivered on this occasion, there was a very moving musical tribute from the Royal Conservatory of Music, featuring violinist Evan Pyne and pianist Ellen Annor-Adjei.

During the two-day conference, numerous sessions and presentations highlighted the outstanding legacy of Justice Rosalie Silberman Abella's remarkable career.

The event came to an end on Friday, May 13, 2022 with a lively fireside chat between Rosalie Abella and well-known journalist and author Paul Wells.

#### PRESIDENT'S AWARD

In 2016, CIAJ established the President's Award to highlight the exceptional contribution of one of its volunteers.

The Award is given every other year, alternately with the Justice Medal. This prize could not be awarded in 2020 due to the pandemic. The next award will be given at the 47<sup>th</sup> Annual Conference, in 2023.

#### JUSTICE MEDAL

At CIAJ's tenth anniversary, in 1984, the Board of Directors established a Justice Medal Award to be given every second year as a mark of exceptional achievement to a person who has shown distinctive leadership in the administration of justice in Canada, or by his or her writings or other endeavours, has made a significant contribution to the administration of justice in Canada. Recipients are announced at CIAJ's Annual Conference in the fall. The Medal was not awarded in 2021 due to the pandemic. The next Medal will be given at the 46th Annual Conference, on October 26-28, 2022.

2019: The Justice Medal was awarded jointly to Mr. John McCamus, Professor Emeritus and former Dean of Osgoode Hall Law School, and Affiliated Scholar at Davies Ward Phillips & Vineberg LLP, and to The Honourable Patrick J. LeSage, C.M., O.Ont., Q.C., former Chief Justice of the Ontario Superior Court of Justice.







#### **RESEARCH FELLOWSHIP**

Created in 2009 in honour of a former CIAJ President, the Charles D. Gonthier Research Fellowship of \$7,500 supports research in relation to the topic of CIAJ's Annual Conference.

The 2022 Research Fellowship was given to Faculty of Law, Université de Sherbrooke PhD student Lauren Cavallier for her research on "La dignité autochtone au sein du système de santé québécois."

#### 2022 Recipient: Lauren Cavallier

Lauren Cavallier is a doctoral student at the Université de Sherbrooke Faculty of Law. She received her graduate diploma from the same Faculty with a thesis entitled "Entre rencontre juridique et acculturation préjudiciable : le rôle des interactions juridiques entre les systèmes autochtones et européens dans le processus de reconnaissance du droit des sociétés autochtones, 1663-1851" (Between Legal Encounter and Harmful Acculturation: The Role of Legal Interactions between Indigenous and European Systems in the Process of Recognizing the Law of Indigenous Societies, 1663-1851). Her current research project focuses on Indigenous Governance in Canada, and more precisely on the different possible interfaces between Indigenous and Canadian governance. The purpose of this project is to shed light on the effectiveness and efficiency of processes affiliated with Indigenous governance.

#### **ESSAY PRIZE**

The Christine Huglo Robertson Essay Prize aims to engage law students in the work of CIAJ and promote scholarship regarding the administration of justice.

The 2022 Essay Prize of \$1,000 was awarded to a recent graduate of the McGill Faculty of Law, Larissa Parker, for her essay entitled: "Not in Anyone's Backyard: Exploring Environmental Inequality under Section 15 of the *Charter* and Flexibility after *Fraser v. Canada*" The prize was created in honour of CIAJ's Executive Director from 1992-2012.

Larissa Parker (BCL/JD-Bachelor of Civil Law and Juris Doctor) is a recent graduate of the McGill Faculty of Law. In 2021-2022, through the generosity of a few members, 208 one-year memberships were paid by members or donated to students and young lawyers. This is a wonderful way to contribute and grow our member community. These memberships also helped foster programs designed for students and young lawyers.

#### THE STUDENT SECTION

CIAJ's Student Section is a gathering place for law students across Canada. It provides students with various tools and projects.

In addition to building bridges between students across the country, the Section is an exclusive learning platform, offering numerous opportunities for students to network and collaborate with key players in the Canadian legal arena. 218 law students have joined CIAJ over the past year.

This summer, CIAJ was fortunate to welcome three law students (Troy Glover, Sarah Rowe & Kelsey Leik) who had the opportunity to work on a number of topics and projects including: the 2022 Annual Conference on Dignity, the upcoming First Nations Justice Symposium, and future CIAJ podcasts.

#### **JUDICIAL INTERNSHIPS**

In the summer of 2019, CIAJ launched the Judicial Internships program to place law students with judges for a week or two of hands-on legal education. The program is designed to allow students additional avenues beyond those offered at their faculties to gain practical experiences during their studies. Participating courts are given wide latitude to modify the experience to fit the needs of the student and the judges with whom they have been paired.

Applications go through a double screening process whereby CIAJ reviews the initial submissions to pass on the stronger candidates to the participating courts which themselves can accept or refuse to take on any individual student.

Since the creation of the Judicial Internship Program in 2019, CIAJ has received a total of 410 applications from across the country. These numbers show that law students take great interest in the program. They are eager to benefit from CIAJ's network, learn new


skills and gain experience by observing the work of judges in courts od tribunals. Some of them have shared their internship experience in blog posts that can be found in the "blog" section on CIAJ's website.

In 2022, CIAJ received a total of 74 applications. 26 students were placed this year: 10 at the Ontario Superior Court of Justice, 6 at the Superior Court of Quebec, 10 at the Provincial court of Quebec.

The feedback that we have received from students indicated extremely positive results. Students not only learnt from judges, but also from the lawyers they observed. As participation is voluntary, the judges who take on students seem to want to give them as good of an experience as they can get, and so the students get to see a variety of cases while also being able to draft legal memos and perform legal research for the judges. Moreover, students can begin building their network and open up other opportunities for themselves all while becoming more familiar with the day to day workings of the law.








## ABOUT OUR MEMBERS


